REQUEST FOR INFORMATION (RFI): "Waste Management Services ZIB06_25"

1. The Opportunity

Thungela's Zibulo Colliery is planning to embark on a Request for Proposal (RFP) process for the **Waste Management Services ZIB06_25**, as detailed in the scope of work mentioned below.

2. Qualifying Criteria

- A minimum of 51% Black Owned businesses from within Zibulo Colliery's Host Communities
- Own or have access to Crap Truck and Compactor
- Have the Exemption Permit in terms of Section 21(1) of the Environmental Conservation Act for all hazardous storage facilities.
- Have the Waste Disposal Certificates for Domestic and Hazardous Waste
- Have relevant experience and references for the **Waste Management Services**

3. Scope of Work

All labour, transport, equipment, and supervision to collect, process, transport, and dispose of waste from the company premises as detailed hereunder:

1. Provide the Mine with an adequate amount of waste skips required for disposal as per the Company's specification.
2. Ensure that correctly colour-coded bins are provided at suitable areas.
3. Ensure that bins are kept clean and that damaged bins are replaced.
4. Correctly and timeously replace a full bin with an empty bin to promote waste separation.
5. Ensure that hazardous waste is removed from the site on an ongoing basis as required and not stored on site for more than 90 days.
6. Ensure that an exemption permit in terms of Section 21(1) of the Environmental Conservation Act for all hazardous storage facilities is obtained.
7. Submits the amount of waste taken off site to a landfill or to be recycled in a form of a composite monthly report (and not waybills) in the first week of the month dealing with the amount of waste generated and removed; type of waste generated and removed as well as areas where waste has been removed from.
8. Ensure that waste is disposed of properly as per the requirements of the South African National Standard (SANS) standards.
9. Provide proof of safe waste disposal by submission of safe waste disposal certificates as obtained from the waste disposal facility to the Environmental Coordinators (ECs) per Division/Mine.
